By joining VxP Operators you agree to these terms. 2. MEMBERSHIP PLANS & BILLING

VxP Operators offers four membership tiers: VxP Operator (\$40/mo), Brand OPS (\$60/mo), Talent OPS (\$60/mo), and Full OPS (\$70/mo). Billing is recurring monthly and begins on the date of purchase. Founding Member pricing is locked for life for the first 100 members and will not increase as long as membership remains active and uninterrupted.

3. CANCELLATION POLICY

You may cancel your membership at any time. Cancellation takes effect at the end of your current billing cycle. No partial refunds are issued for unused days within a billing period. Upon cancellation, access to the Discord community and all member benefits will be removed at the end of the paid period. Founding Member pricing is forfeited upon cancellation and cannot be reinstated.
